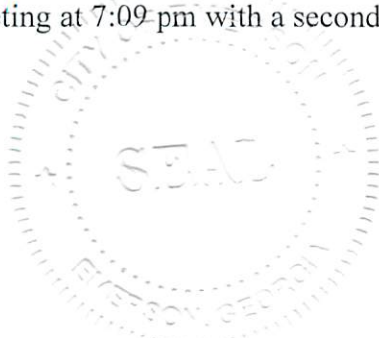
CITY COUNCIL MEETING
