Call to Order / Roll Call / Quorum Check was made by Bill Popham and the following were in attendance: Commission Members Dennis Mauldin, Jaretta Shaw, Michele Dover, Ted Porter, Assistant City Manager Todd Heath, Deputy City Clerk Patty Gilleland and visitors.

- **Approval of Minutes from Previous Meeting** – A motion was made by Dover to approve the minutes as presented with a second from Porter. Motion Carried.

- **REPORTS:** Handbooks were distributed to the members that were unable to attend the class in August.
- **NEW BUSINESS**
 1. **VARIANCE – Location & Fencing – RV Park** – A variance to remove the requirement of fencing on the back side by the river and also the side with the Utility Right of Way. Motion was made by Dover with a Second from Porter to approve. Motion Carried
 2. **VARIANCE – Size of Individual Lots – RV Park** – A variance to remove the requirement of all pull through individual lots. They will still provide a number of pull through lots but not all will be that type. The actual lot size will be larger than required by ordinance. A motion to approve was made by Porter with a second from Shaw. Motion Carried
 3. **VARIANCE – Sanitary Facilities – RV Park** – A variance to reduce the location and number of bath houses for the park. This RV park is designed for RV that will house their own facilities. 2 bath house along with a club house with facilities as well. Motion was made by Shaw with a second from Dover to approve. Motion Carried.
 4. **VARIANCE – Set Backs – LakePoint Station** – A variance to reduce the set back from 40 to 17 feet to add an additional building at 77 Old Allatoona. This is in the rear that is nearest the Rail Road Tracks. A motion was made by Mauldin with a second by Porter to approve. Motion Carried.
