
- **Call to Order/Roll Call/Quorum Check** was made by Mayor Al Pallone and the following were in attendance; Council members Ed Brush, Vince Wiley, Donnie Bagwell and Gerald Earwood; City Manager Kevin McBurnett, Deputy City Clerk Patty Gilleland, visitors and media.
- **Invocation/Pledge of Allegiance** was led by Bagwell.
- **HEARINGS:**
  1. **Hearing/Ordinance-Amend Code Sec. 28-5 through 28-8 Traffic & Vehicles-** Mayor Pallone opened the hearing, no comments were made and hearing was closed.
  2. **Hearing/Ordinance-Amend Code-GDOT List of Roads-** Mayor Pallone opened the hearing, no comments were made and hearing was closed.
- **OLD BUSINESS:**
  1. **2<sup>nd</sup> Reading-Amend Code Sec. 28-5 through 28-8 Traffic & Vehicles**  
Motion was made by Bagwell to approve with a second from Wiley. Motion carried.
  2. **2<sup>nd</sup> Reading-Amend Code GDOT List of Roads** – Motion to approve was made by Brush with a second from Bagwell. Motion carried.
- NEW BUSINESS:**
  1. **Ordinance-1<sup>st</sup> Reading–Amend Code/Weed & Grass Height** – McBurnett explained how this has become a problem on improved properties within the city. No action taken.
  2. **Ordinance-1<sup>st</sup> Reading–Amend Code/Abandoned Vehicles** – McBurnett discussed the current code and said the change only allows for 7 days of vehicles not moving. Garage kept would not be considered a violation. No action taken.
  3. **Resolution – Purchase Police Vehicle**-Car totaled on 7-13-19. Replacement vehicle but would be a change to Ford Explorer for more durability. More expense but repair cost should be diminished. Bagwell made a motion to approve with a second from Wiley. Motion carried.
